LEGISLATION FRAMEWORK

A fellowship contract will be celebrated according to the regulations defined by the Portuguese Research Council (Fundação para a Ciência e a Tecnologia – FCT) in <u>Regulamento n.º 339/2015</u> and Universidade de Lisboa in <u>Despacho (extrato) n.º 6977/2015</u>, following <u>Estatuto do Bolseiro de</u> <u>Investigação</u> approved by Law nº 40/2004 and its amendments, namely Decree-Law No. 202/2012 of 27 August, Decree-Law No. 233/2012, Law No. 12/2013, and Decree-Law No. 89/2013.

SALARY

The fellowship amounts to €1495/month (12 months/year), according to the <u>standard values</u> <u>published by FCT</u>. The fellowship holder will have a personal accident insurance and is entitled to adhere to the voluntary social insurance scheme (<u>Seguro Social Voluntário</u>), pursuant to Código dos Regimes Contributivos do Sistema Previdencial de Segurança Social. The fellowship will be paid monthly by bank transfer.

SELECTION PROCESS

Eligible applications will be evaluated by a three-member committee chaired by Professor Patricia Melo. Eligible applications will be ranked according to the job requirements listed above and a maximum of five applicants with an overall score above a pre-set threshold will be invited for an interview.
